

Rider LGS-INC-Incremental Service Rider

SERVICE CHARACTER

This Incremental Service Rider (Rider) provides an energy-only price option for customers adding new electrical loads with potentially low load factors. The Rider provides customers the opportunity to take incremental electric service above a base level of service established in a Rider Service Agreement and which base level of service is being provided to the customer under Rate Schedule LGS – Large General Service. The continuing availability of service under the Incremental Service Rider will be subject to GRDA's sole discretion, and GRDA may suspend, terminate, or modify this Rider with sixty day's written notice.

AVAILABILITY

Service under this Rider is available to both existing customers who are planning to add incremental load pursuant to a Rider Service Agreement or to new customers establishing service under GRDA's Rate Schedule LGS.

Service under this Rider is available for customers with an expected Capacity Billing Demand (Base Demand plus Incremental Demand) of 25,000 kilowatts (kW) or less, and, who are expected to have an Incremental Demand of at least 5,000 kW for the billing month.

TERMS AND CONDITIONS

Customer will enter into a Rider Service Agreement for service under this Rider. The term of the Rider Service Agreement will be agreed to between Customer and GRDA.

The Base Demand, Base On-Peak Energy, and Base Off-Peak Energy to be charged Customer each month for service under Rate Schedule LGS will be established in the Rider Service Agreement.

To remain eligible for service under this Rider, Customer must fully meet and comply with all Terms and Conditions of service of this Rider and Rate Schedule LGS.

Service under this Rider is not available to support or provide back-up service for Customer-owned generation.

Service under this Rider will be at one point of delivery.

DEFINITIONS

- 1. <u>Base Demand</u>: As agreed to in Rider Service Agreement, Customer's Billing Demand established for service under Schedule LGS.
- 2. <u>Base Off-Peak Energy</u>: As agreed to in Rider Service Agreement, Customer's Off-Peak Energy (kWh) for service under Schedule LGS.
- 3. <u>Base On-Peak Energy</u>: As agreed to in Rider Service Agreement, Customer's On-Peak Energy (kWh) for service under Schedule LGS.
- 4. <u>Capacity Billing Demand</u>: The billing demand for the Customers load as determined in accordance with service under Schedule LGS.
- 5. <u>Incremental Demand</u>: Customer's Capacity Billing Demand exceeding the Base Demand (Capacity Billing Demand minus Base Demand, but not less than zero).
- 6. <u>Incremental Demand Load Factor</u>: The Incremental Energy divided by the product of Incremental Demand multiplied by the hours of the billing month.
- 7. <u>Incremental Energy</u>: The sum of Incremental Off-Peak Energy and Incremental On-Peak Energy.
- 8. <u>Incremental Off-Peak Energy</u>: Customer's Metered Off-Peak Energy exceeding the Base Off-Peak Energy (Metered Off-Peak Energy minus Base Off-Peak Energy, but not less than zero).
- 9. <u>Incremental On-Peak Energy</u>: Customer's Metered On-Peak Energy exceeding the Base On-Peak Energy (Metered On-Peak Energy minus Base On-Peak Energy, but not less than zero).

MONTHLY CHARGES

Customer's net monthly bill for service provided under this Rider will be determined under Rate Schedule LGS and this Rider.

Initially, the Monthly Billing Amount will be determined for all metered use (demand and energy) under the LGS Rate Schedule, without applying the Rider to any portion of Customer's Load and Energy monthly metered values.

If Incremental Demand Load Factor is greater than 60 percent, there is no adjustment to the Monthly Billing Amount.

If the Incremental Demand Load Factor is less than 60 percent, then the Monthly Billing Amount will be adjusted, as follows:

- (1) Monthly Demand Charge Credit: Incremental Demand multiplied by LGS Capacity Charge;
- (2) Monthly Off-Peak Energy Charge Increase: Incremental Off-Peak Energy multiplied by the result of Rider Off-Peak Energy Charge minus LGS Energy Charge Off-Peak.

Rider Off-Peak Energy Charge: \$0.0110

(3) Monthly On-Peak Energy Charge Increase: Incremental On-Peak Energy multiplied by the result of Rider On-Peak Energy Charge minus LGS Energy Charge - On-Peak.

Rider On-Peak Energy Charge: \$0.0200

Thus, Customer's net savings under this Rider will be the demand charge credit offset by the higher energy charges.

CHANGES TO RIDER

The terms and charges in this Rider, or any portion thereof, may be changed by GRDA from time to time as provided by the "Grand River Dam Authority Act" (82 O.S. § 861, et seq., as amended).

This Rider may be suspended, terminated or modified at GRDA's sole discretion with thirty day's written notice.
