**SCHEDULE SGS-C – SMALL GENERAL SERVICE - COMMERCIAL**

**AVAILABILITY:**

For retail customers connected to GRDA’s system for which there is no other applicable rate.

The power and energy furnished under this schedule shall not be resold.

GRDA shall be the sole judge as to the availability of this rate.

**TYPE OF SERVICE:**

Single-phase or three-phase, 60 hertz, at the most available voltage. Where service of the quantity and type required by Customer is not already available at the location to be served, additional charges and contract arrangements may be required prior to service being furnished.

**MONTHLY BASE RATE:**

Basic Charge, per Meter	\$ 56.00
Energy Charge, per Billing Energy (kWh)	\$ 0.06197

**MINIMUM MONTHLY BILL:**

The Minimum Monthly Bill for service under this schedule shall be the greater of the Basic Charge or the amount, if any, established in the Customer’s Power Purchase and Sale Agreement with GRDA.

**BILLING METER:**

The above rates and charges are based on the supply of service through a single Point of Delivery and at a single voltage. Separate supply at other Points of Delivery, or at different voltages, will be separately metered and billed at the applicable rate.

**DETERMINATION OF BILLING ENERGY:**

The Billing Energy (kWh) for each Point of Delivery shall be the total amount of electrical energy delivered to the Customer at the Point(s) of Delivery, measured at the Metering Point(s), during the monthly billing period.

**POWER FACTOR:**

The power factor is the ratio of real power (kilowatt) to apparent power (kilovolt-ampere) for any given load and time. The Customer will be expected to maintain a minimum monthly average power factor of ninety-eight percent (98%). Power factor values from 98% to unity are acceptable.

If the minimum monthly power factor is not maintained, GRDA, at its option may, after giving the Customer ninety (90) days to correct the power factor condition, make improvements at the Customer's Point of Delivery to correct the power factor deficiency. The cost of any such power factor improvements made by GRDA shall be charged to the Customer.

**POWER COST ADJUSTMENT:**

This rate is subject to Schedule PCA – Power Cost Adjustment.

**OTHER TAXES, FEES AND DUTIES:**

The Customer shall pay, in addition to the other rates and charges set forth on this schedule, any taxes, fees and duties required to be collected by GRDA and paid to the proper agency charged with the collection of such taxes, fees and duties.

**OPTIONAL FLAT BILL PROVISION**

Under certain circumstances when a customer's load is limited or has little variation (under 500 kWh per month), GRDA may elect to bill the Customer using a Flat monthly charge. The Flat Bill Charge will be inclusive of all charges, including PCA. The Flat Bill Charge will be \$56 per month. GRDA may verify the monthly kWh usage periodically and if the usage exceeds the 500 kWh per month limit, GRDA may elect to resume billing under the standard tariff.

**TERMS OF PAYMENT:**

Bills shall be considered past due if not paid by the due date shown on the bill. A late payment fee of 1.5% per month shall be assessed on past due amounts. Such late payment fee shall not be less than \$25.00.

**CHANGES TO RATE SCHEDULE:**

The terms and charges in this rate schedule may be changed by GRDA from time to time as provided by the "Grand River Dam Authority Act" (82 O.S. § 861, *et seq.*, as amended).
